



Mikrosil has been formulated to give excellent rendering of small details, highest contrast for microscopical observations, good releasing ability and short setting time.

Ideal for use on toolmarks, firing pin marks and dusted fingerprints where a regular lifting tape will fail.

These properties are of special importance with shallow marks and those with small details requiring large magnification. It is also suited for lifting developed latent fingerprints from textured surfaces.



Setting times: 5-8 minutes at 68 degrees Fahrenheit 12-15 minutes at 14 degrees Fahrenheit. The setting time can be shortened by increasing the amount of hardener or lengthened by decreasing it. Do not add more than 6% hardener.

Generally squeeze out equal lengths of Mikrosil and hardener when using this product.



This product is ideal for removing adhesive tapes, labels, stickers, postage stamps etc from a variety of surfaces thereby allowing you to use conventional methods to process the adhesive side of the tape in order to look for fingerprints.



Used in accordance with the instructions, you can safely remove objects without damaging the adhesive. The product then evaporates quickly leaving the adhesive ready for developing with further processes such as Stickyside powder or Wetwop.

Amido Black 25gm

Amido black is a dye which stains protein present in blood and other body fluids to give a blue-black product. It will not detect the normal constituents of latent fingerprints and therefore must be used in sequence with other techniques when blood-contaminated latent fingerprints are examined. It is also absorbed by some porous surfaces and may produce a high background colour.

Effective on porous and non-porous surfaces paper, heavy cardboard, rubber gloves, plain wood, polythene etc. Good results have also been obtained on cadavers.

Care should be taken when dealing with porous substrates as the dye may be absorbed.

It is recommended that photographs be taken of the bloodstains before treatment with Amido Black.

Ardrox Dye 1ltr

Ardrox is a fluorescent liquid dye which works well with lasers, forensic light sources and even UV lamps.

Ardrox can be used full strength or diluted with either Methanol or Ethanol.

Although Ardrox developed prints fluoresce under 365nm , better results have been reported while examining evidence with 450 - 480nm light.

Basic Yellow 40 (Panacryl brilliant flavine) has been found to be one of the most sensitive stains and fluoresces well between 365nm and 485nm.

Gentian Violet 25gm

Gentian Violet is a dye which stains the fatty constituents of sebaceous sweat producing an intense purple image. It is very effective for the development of latent fingerprints on the adhesive surface of adhesive tape and decorative or protective films.

It will also develop fingerprints on some other surfaces, particularly those contaminated with oils and grease. Also effective on small non-porous surfaces such as crockery.

Do not use on porous materials i.e. wood, paper, card.

This reagent is easy to use but please note that this product is toxic by swallowing or skin absorptions and should therefore NOT be used in large quantities.

Ninhydrin is a very effective reagent for paper and some other porous surfaces. It reacts with amino acids and possibly some other components in fingerprints. It produces visible latent fingerprints on surfaces such as cheques, paper documents, bank notes, wood etc.

Simple to use and cost effective as it does not require any additional light sources for examination. Reacts with blood and may be used for developing blood contaminated fingerprints. If used after DFO additional fingerprints may be developed.

Ninhydrin Spray 120ml

Ready made solution in a handy pump action container rather than an aerosol can. Just pump three or four times to create pressure and then by pressing the nozzle a fine jet of Ninhydrin is released.

Always wear eye protection and a face mask when using this product.

Preferably use this product in a fuming cabinet.



Rhodamine 6G 25gm

It is best used on metal, glass, leather plastic and other objects to be used in conjunction with a Forensic Light Source.

However caution coupled with good protective clothing is strongly recommended when using this product, because of its possible carcinogenicity.



SPR (Self Mix) 25gm

Small particle reagent is a suspension of fine molybdenum disulphide particles in detergent solution.

It adheres to the fatty constituents of latent fingerprints to form a grey deposit and is a quick and simple process.

The dish application method is a reasonably sensitive process but is very much more effective on fresh fingerprints than older ones.

The spray application (see No. 95333) is considerably less effective and should be considered only when no alternative is feasible.

The grey powder may be lifted to simplify photography.





SPR Spray 450ml

Small particle reagent is a suspension of fine molybdenum disulphide particles in detergent solution. It adheres to the fatty constituents of latent fingerprints to form a grey deposit and is a quick and simple process. CODE 95333

This spray application is considerably less effective than the regular dish development technique, but it does have its place when that alternative is not always feasible.

For example this application is ideally suited for use on damp motor vehicles.

The grey powder may be lifted to simplify photography.

Stickyside Powder 25gm

A powder for developing fingerprints on the adhesive side of most tapes and labels. i.e. packing tape, masking tape, ducting tape, plasters and packing labels etc.

Powder should be mixed with PhotoFlo 200 (see No. 95339) and water and then applied to the tape using a softhair brush such as our camel hair brush, product code 95123.

Can be used as a replacement to Gentian Violet and superglue although the latter is a far superior process.

Photo-Flo 200

For use with Sticky-Side powder (product code 95340) which in turn is used for developing fingerprints on the adhesive side of most tapes and labels.

Basically PhotoFlo 200 is added to water and sticky-side powder to form a paste. Current pack size is 16fl oz (473ml)

Sudan Black 25gm

Sudan Black is a dye which stains fatty components of sebaceous sweat to produce a blue-black image. The formulation contains solid particles of dye as well as dye in solution.

It is less sensitive than some other processes for latent print detection but is of particular use on surfaces which are contaminated with grease, foodstuffs or dried deposits of soft drinks.

It will also enhance superglue developed fingerprints.

Superglue Liquid

Superglue vapour, ethyl cyanoacrylate, polymerises on some latent fingerprints to produce a white deposit. This polymerisation is thought to be catalysed by water and possibly some other constituents of latent fingerprints. The effectiveness of the process is very dependent on the processing conditions.

Because of the hazards associated with Superglue we would always recommend its use in a fuming chamber. (See No. 97051 CSI Forensic Fingerprint Cabinet).

To prolong the shelf life of this product we suggest storing it in a refrigerator.




